

**NORTH FAYETTE TOWNSHIP
PUBLIC HEARING
MUNICIPAL BUILDING
SEPTEMBER 13, 2022

A Public Hearing was held on Tuesday, September 13, 2022, with Board of Supervisors Chairman Jim Morosetti presiding for the purpose of taking public comment on the following:

An application of CBOCS Pennsylvania, LLC to transfer a restaurant liquor license (No. R-3413) from the borough of Sewickley to the Township of North Fayette for use at the Cracker Barrel Restaurant located at 200 Davis Boulevard, Pittsburgh, PA 15275.

Following the Pledge of Allegiance, roll was called with the following present: Chairman Jim Morosetti, Vice-Chairman Bob Doddato (absent at roll call), Treasurer Mark O'Donnell, Township Manager J.R. Mangan, Assistant Township Manager Andrew Hartwell, Chief of Police Donald Cokus, Solicitor Michele Cromer, and Township Secretary Marlyn Jordan

OTHERS PRESENT: Pat Felton – Public Works Director, Gary Hamilton NFTVFD Chief, Darlene Hildebrand – Recreation Director, Shawn Wingrove – Township Engineer, Leah Attanucci – Court Reporter, Ken McDermott, Colleen Morris, and Matt McCullom.

All people wishing to speak were sworn in by the Court Reporter.

Ken McDermott, attorney for Cracker Barrel stated that in response to customer feed back Cracker Barrel has started adding limited alcohol service to their menu. They are asking for the Township's permission to transfer a liquor license to their location at 200 Davis Boulevard. The license is currently owned by Carl Boltzer, Inc. DBA Pizza Roma, located in Sewickley, PA.

The alcohol services will be a limited menu and will be a compliment to the existing menu. They will not be adding a bar or having DJ's or live bands.

Matt McCollum, General Manager for the North Fayette Cracker Barrel stated that they do not intend to change their hours if they receive a liquor license. Alcohol service will be table side and guests will be required to show id with all orders.

Mr. Morosetti wanted to know how old the youngest server is.

Mr. McCollum stated they were 17.

Mr. Morosetti wanted to know if they were aware of the law.

Mr. McCollum said yes that they need to be 18 to serve alcohol.

Mr. McDermott stated that part of Cracker Barrel's policy is that any server under 21 will be partnered with a server who is at least 21 when there is an alcohol order.

Mr. Morosetti asked if there were any other questions. Being none, he stated that the board had 45 days to make a decision.
